### Method of Procurement: Single Stage Two Envelopes, Under Public Procurement Rules, 2004

4. Documents will be issued from the date of Publication of NIT during office hours, on payment of a non-refundable tender fee of Rs. 3,000/-. The tender fee should be in the form of Pay Order in favor of KIDCL Submission of application for issuance of bid documents along with copy of valid PEC registration certificate in Category C4 or above, Discipline CE-01 are mandatory for issuance of bid documents.

All bids must be accompanied by Original Bid Security in the amount of Rs.2 million in the shape of bank guarantee issued by a Schedule Bank in Pakistan or from a Foreign Bank duly counter guaranteed by a Scheduled Bank in Pakistan or an Insurance Company having at-least AA rating from PACRA/JCR in favor of KIDCL for a period of 28 days beyond the Bid Validity Date.
